

Dear Valued Residents,


We are closing on week 7 of California's stay at home order. As I have said before, the Governor's criteria for reopening California is an anti-scientific bit of government overreach.

# Coronavirus COVID-19 Guidance for Pool Facilities Reopening and Operating at Approved Capacity

The Orange County Health Care Agency, Environmental Health understands your need to reopen and operate at the approved capacity as soon as possible. We are here to provide assistance. Prior to reopening and operating, ensure that pool users can continue to follow any Public Health Orders that remain in place and the following guidelines can be achieved to prevent any pool safety risks. Your facility should not be operating unless all of the guidelines can be checked off and maintained.

The Health Care Agency reported at yesterday's board meeting that we have a capacity in Orange County for 9,000 tests per day. Also according to HCA, 303 people sought tests the prior day.

Apparently, the people are not seeking tests in anything close to the numbers we can accommodate. What they are seeking in increasing numbers is the ability to get back to work safely and soon.

Supervisor Wagner thanks the Congressional delegation for their work on behalf of OC. He urges them to join with the bi-partisan coalition of Supervisors from around O.C. asking for reasonable metrics from the governor to reopen businesses.

# OC Supervisors Michelle Steel and Don Wagner Introduced Motion to Direct \$75 Million of CARES Act Funding to Assist Business Recovery Grant Program

At the May 12th Board of Supervisors meeting, Michelle Steel, Chairwoman of the Orange County Board of Supervisors and Supervisor Donald P. Wagner introduced a motion to direct \$75 million of CARES Act Funding to Assist Business Recovery Grant Program to be administered and divided amongst the cities. Unfortunately, the motion was defeated in a 3-2 vote.

"This plan to allocate \$75 million dollars of CARES Act money earmarked for assisting small businesses to our cities was a way to help out businesses that are struggling in the wake of the economic impact from coronavirus. Unfortunately, this motion did not pass," said Chairwoman Steel. "I have faith that in next week's meeting we will have another chance to have majority support to assist our small businesses in Orange County."

"I want to thank Chairwoman Steel for sharing my commitment to using CARES Act money to support small businesses throughout Orange County," said Supervisor Wagner. "I look forward to the Board finally implementing this plan next week. I believe the cities are the most appropriate representatives of the people to distribute this much-needed support."

# Have COVID-19 symptoms? Get FREE testing.

The Orange County Health Care Agency cares about you and wants anyone with symptoms of COVID-19 to be tested. That's why our new **OC COVID-19 Testing Network** is offering FDA-authorized COVID-19 testing at NO CHARGE to anyone with symptoms who doesn't have access to a healthcare provider.



#### 1. Only request a test if you have symptoms

These include **cough**, **shortness of breath** or **difficulty breathing**, as well as fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, and loss of taste or smell.

If you are experiencing these symptoms, call your health care provider (if you have one) and isolate yourself from others as soon as possible.



### 2. Call first to make an appointment

Same-day or next-day appointments are usually available, but residents **must call first** to assure eligibility and availability of testing.

# 3. Testing is confidential

The COVID-19 test for people with symptoms involves a **nasal swab**, with no needles or blood samples required. Results are typically available in two to four days, or in some cases sooner.

Testing 101

There are two kinds of COVID-19 testing you may be hearing about – a diagnostic test (PCR) and an antibody test (serology). Here's some basic information about each one.

The Toll Roads Extend Time to Pay Tolls, in Response to COVID-19 Pandemic

"These are unprecedented times and The Toll Roads are adjusting and adapting daily to meet the needs of our drivers," said Samuel Johnson, Interim CEO of the Transportation Corridor Agencies, the two joint powers authorities responsible for operations of The Toll Roads. "We've taken steps to help our customers through this challenging time and provide some relief. We aim to ease burdens where and when we can, while continuing to be fiscally responsible."

# The Toll Roads have temporarily implemented the following adjustments:

- A moratorium has been placed on violation escalations.
- The fee for having an account suspended (\$20) is being waived.
- The timeframe to pay a toll at <u>TheTollRoads.com</u>, using The Toll Roads free app and via phone has been extended from five days to 10 days.
- The minimum monthly payment for violation payment plans has been lowered from \$25 to \$10 and tolls and penalties can be paid off over 12 months instead of six.
- The quarterly replenishment recalculation for prepaid FasTrak accounts has been restarted with the intent of lowering the replenishment amount for people who are driving less.

Following the governor's guidance to avoid or slow the spread of COVID-19, The Toll Roads temporarily closed their Irvine Customer Service Walk-In Center on March 13. It is expected to reopen in May, but given the complexity of the situation, the date is subject to change.

"With health being a top worry for most people and economic uncertainty being a close second, as a government agency, we want to do everything within our power to ease the burden of our customers while protecting their safety," said Trish Kelley, San Joaquin Hills Transportation Corridor Agency Chairwoman and Mission Viejo Mayor Pro Tem.

The Toll Roads are holding all public meetings virtually with adjusted protocols until it is deemed safe by California Department of Public Health to return to larger, in-person gatherings. The public is encouraged to participate by watching the meetings <u>online</u> and providing comments to the Clerk of the Board via <u>email</u>.

"While most of our customers are staying safe at home, we want them to know that The Toll Roads are here for them now and will be here for them when it's time to get back on the road," said Christina Shea, Foothill/Eastern Transportation Corridor Agency Chairwoman and Irvine Mayor.

The 73, 133, 241 and 261 Toll Roads remain open to drivers. Customers can pay tolls, open a new account and manage an existing account at <u>TheTollRoads.com</u> or using The Toll Roads free app. Alternatively, customers can call 949-727-4800 to speak with a Customer Service Representative Monday through Friday (8 a.m. to 6 p.m.) and on Saturdays (9 a.m. to 2 p.m.). Outside of the Call Center's regular business hours, an automated phone service provides self-help features 24/7.

Out of an obligation to bondholders, tolls cannot be lowered or lifted. A toll is a user fee and must be paid by all users of The Toll Roads.

Note from OC Public Works:

The County of Orange lifted parking along Black Star Canyon Road today to once again accommodate trails users visiting the area. Roadside parking is once again available between the Black Star Canyon trailhead and Silverado Canyon Road.

While the public has enjoyed uninterrupted access to the trail, temporary parking restrictions were implemented along Black Star Canyon Road in late March. The interim safety measures were implemented due to potential safety risks associated with vehicles blocking public areas, parked vehicles encroaching into the roadway, and a lack of social distancing due to the large crowds during the State and County Public Health Orders prohibiting large public gatherings due to the COVID-19 (coronavirus) pandemic.

Public safety remains the County's top priority. Parking restrictions along other roads in unincorporated Orange County canyon communities of Silverado Canyon, Modjeska Canyon, and Trabuco Canyon will remain in effect to maintain safe road conditions for residents, visitors, first responders, service providers, cyclists, and other roadway users.

On Tuesday, the Orange County Board of Supervisors voted to reopen parking lot facilities at Countyoperated regional parks and wilderness areas to allow additional access to outdoor areas. Those parking lots and park restroom facilities will reopen to the public on the morning of Saturday, May 16. 








# HONORING NATIONAL POLICE WEEK May 10 - May 16
