NEW! TUSTIN VETERANS SPORTS PARK

Supervisor Wagner presented a resolution to Tustin Mayor Allen Bernstein to commemorate the new Tustin Veterans Sports Park. The park is an expansive 32.5 acres of pickleball courts, tennis courts, baseball fields, and, a display area that pays homage to Tustin's military history.

At the heart of Veterans Memorial Plaza stands a 15' tall sculpture engraved with the five military branches. Decorative plaques pay tribute to the Sailors, Soldiers, Marines, Airmen, and Coast Guards who are willing to lay down their lives so
